SUBJECT: Cancellation of Acquisition Bulletins - Round 2

Purpose: Cancellation of the following Acquisition Bulletins (ABs):

- 09-02 R1 entitled, "Office of Management and Budget (OMB) Requirements for Acquisition and Assistance Agreements in Support of the American Recovery and Reinvestment Act of 2009" dated June 30, 2010;
- 05-01 entitled, "Contracting for Audit or Certain Non-Audit Services" dated February 23, 2005;
- 02-18 entitled, "Personal Services Contractors and Repayment of Buyouts" dated June 14, 2002;
- 02-07 entitled, "Implementation of Executive Order 13224, Blocking Property and Prohibiting Transactions with Persons Who Commit, Threaten to Commit, or Support Terrorism" dated June 14, 2002; and
- 02-03 entitled, "Department of the Treasury Acquisition Regulation Update" dated June 14, 2002.

Background: To maintain the currency of Treasury acquisition policy and procedures, the Office of Procurement Executive conducted a review of existing active ABs and identified the aforementioned ABs for purposes of cancellation. The reasons for cancellation of the ABs are as follows:

- 09-02 R1 - ARRA no longer requires reporting as of 05/14/14 therein the action described in the AB is no longer required;
- 05-01 – Information contained within the AB has been updated since its issuance combined with the determination to move the procedure to the DTAP;
- 02-18 - The FAR having been updated to address this matter since the issuance of this AB combined with the determination to move the procedure to the DTAP;
- 02-07 – System for Award Management (SAM) includes this type of exclusion as part of their exclusions listing; and

- 02-03 - This information is outdated and captured elsewhere either in internal policy or external documents.

Action:

- AB Nos. 02-03, 02-07 and 09-02 R1 are cancelled with no Bureau action required.
- AB No. 02-18 is cancelled with any related acquisition procedures moved to the DTAP (see DTAP part 1037). Bureaus are to refer to the DTAP going forward for the procedure concerning the acquisition of such services.
- AB No. 05-01 is cancelled with any related acquisition procedures moved to the DTAP (see DTAP subpart 1037.70). Bureaus are to refer to the DTAP going forward for the procedure concerning the acquisition of audit and certain non-audit services.
