Acceptable method of payment will be cashier's check. **Make cashier's check payable to U.S. Treasury/VSE Corporation** for the full bid amount. Reference the PDF version of the catalog to verify the lot number of the item(s) you wish to bid on and verify that a single item you wish to bid is not lotted with other merchandise. **If the item you wish to place a written bid on is lotted with other merchandise you must bid on the entire lot, not the individual item.** Unsuccessful bids will be returned within five (5) business days via registered mail.
