What actions were you able to avoid because of the capital infusion of CPP/CDCI funds?

The capital infusion provided by the CPP funds, enabled IA Bancorp, Inc. and its subsidiary Indus American Bank, along with other capital infusions, to maintain capital ratios at well capitalized levels. As a result, management did not experience any restrictions imposed by regulations.

What actions were you able to take that you may not have taken without the capital infusion of CPP/CDCI funds?

As result of the capital infusion of CPP funds, IA Bancorp, Inc. and it's subsidiary Indus American Bank were able to grow the bank expanding lending and increasing the deposit base.

Please describe any other actions that you were able to undertake with the capital infusion of CPP/CDCI funds.

Increased capital provided by the CPP enable IA Bancorp, Inc. and it's subsidiary Indus American Bank to work with the borrowers who were in financial distress and could not meet contractually agreed payments and rates. Such loan restructures under modified terms, referred to as TDR's (troubled debt restructures), totaled approximately \$10 million.
