77% of the loan volume discussed above came from Commercial Loans, primarily Commercial & Industrial Loans. The remaining 23% of the loan volume came from Consumer Loans, primarily Consumer Mortgage/Home Equity Loans/Lines and Loans Secured by Marketable Securities.
