<input checked="" type="checkbox"/>	Increase lending or reduce lending less than otherwise would have occurred.	Loans increased by \$2.2M in FY12 while decreasing \$8.4M since funding of the CPP. The CPP funds allowed Hometown Bank to seek loan growth during the economic downturn and times of slow loan demand.

<input checked="" type="checkbox"/>	Make other investments	Hometown Bank opened a new location in Barbourville KY in September 2008 and the CPP Funding allowed additional capital to invest into this location. As of December 31, 2012, the Barbourville branch had total loans of \$6.06M and total deposits of \$16.25M while employing 6.25 FTEs.

<input checked="" type="checkbox"/>	Held as non-leveraged increase to total capital	Of the \$1.9M in CPP Funding, \$750,000 was injected into the bank by the holding company as capital. The banks' capital ratio has risen from 7.94% at the time for the CPP Funding to 9.56% as of December 31, 2012.

What actions were you able to avoid because of the capital infusion of CPP/CDCI funds?

Hometown Bank was able to maintain capital ratios greater than 8.0%. Capital ratios increased from a low of 7.94% at February 28, 2009 to 9.56% at December 31, 2012. Without the CPP funding, Hometown Bank would have been forced to reduce lending opportunities and curtail deposit gathering at all locations and the expansion into the Barbourville KY market would not have been as successful. A reduction in FTEs was also highly likely. Furthermore, the holding company was not forced into an additional capital stock sale in a down market.

What actions were you able to take that you may not have taken without the capital infusion of CPP/CDCI funds?

Due to the CPP Funding, Hometown Bancshares, Inc., the holding company was not forced into an additional capital stock sale in a down market and Hometown Bank did not have to take steps to reduce loans and deposits growth efforts.

Please describe any other actions that you were able to undertake with the capital infusion of CPP/CDCI funds.

The CPP Funds allowed Hometown Bank to expand into a new market in Barbourville, KY. Employee levels have increased since the CPP Funding date in February 2009.
