We reallocated resources from an MSA to construct a new branch and open a second branch to provide more access to customers within our existing markets. We expect credit availability to increase as a result of this reallocation of resources with time.

Additionally, we were not pleased with the productivity of our secondary market one-to-four residential mortgage program. We reallocated resources to change our product offerings and structure which will result in greater access to mortgage credit within the communities we serve and will result in a more efficient mortgage product to serve our one-to-four residential mortgage consumers.
