What actions were you able to avoid because of the capital infusion of CPP funds?

On December 31, 2008, PNC completed its acquisition of National City Corporation (NCC), as a result of which National City Bank (NCB) became a wholly owned subsidiary of PNC. Also on December 31, PNC issued preferred stock and warrants to the Treasury under the CPP in exchange for almost \$7.6 billion in additional capital. PNC used \$7.15 billion in TARP funds to enhance the regulatory capital position of NCB to attain an 8% Tier I capital ratio. (An additional \$1.65 billion necessary to complete the recapitalization was represented by cash available at NCC at the time of the merger.) This capital infusion into NCB was required for it to continue serving existing customers as well as to provide deposit and credit products to new customers.

On a consolidated basis, the CPP proceeds resulted in improvement to PNC's overall capital and liquidity positions, supporting our overall banking businesses.
