With the receipt of funds from the US Treasury, the Company was able to reduce lending less than otherwise would have occurred. However, we still intend to increase lending over the term of holding the funds.

<input checked="" type="checkbox"/>	Increase securities purchased (ABS, MBS, etc.).	The Company increased its investment in agency mortgage backed securities by 53% during 2009. This investment supported the residential lending market while maintaining a safe investment for the Company.

<input checked="" type="checkbox"/>	Increase reserves for non-performing assets	The Company's non performing assets increased by \$51 million during 2009. The funds from the US Treasury allowed us to add \$53.5 million in loan reserve expense during 2009 to address the increase in these problem loans and charge off uncollectible loans, as noted below.

<input checked="" type="checkbox"/>	Increase charge-offs	The Company charged off \$35.5 million in uncollectible loans during 2009. While these charge-offs decreased our reserve for loan losses, our reserve as a percentage of noncurrent loans increased 30%, and our reserve as a percentage of total loans increased from 1.14% to 2.82% during 2009.
