American taxpayers are quite interested in knowing how banks have used the money that Treasury has invested under the Capital Purchase Program (CPP) and Community Development Capital Initiative (CDCI). Total loans increased \$51 million to \$594.3 million during 2010. This increase of over 9% was in the 95th percentile compared to the BHCPFR peer group.

Commercial Loans increased \$18 million to \$179.2 million
Farmland increased \$10 million to \$57.8 million
