American taxpayers are quite interested in knowing how banks have used the money that Treasury has invested under the Capital Purchase Program (CPP) and Community Development Capital Initiative (CDCI). Gross loans per the Bank's Call Report increased \$22.4 million in 2010 and have increased \$36.3 million during the 18 months the Bank has been a TARP recipient. This represents 23% growth in the Bank's outstanding loan balances since receiving the capital investment.

To the extent the funds supported increased lending, please describe the major type of loans, if possible (residential mortgage loans, commercial mortgage loans, small business loans, etc.).

Loan growth is primarily commercial real estate and small business in Pittsburgh and surrounding communities. Enterprise Bank has been the largest dollar volume SBA lender in the Western Pennsylvania region since receiving the CPP investment.
