Allowed us to do \$11.7MM in lending to our communities. In 2010 we had to drastically reduce our lending levels (a drop from \$121.5MM), so the TARP funds continued to play a vital role in our ability to continue lending into 2010.

To the extent the funds supported increased lending, please describe the major type of loans, if possible (residential mortgage loans, commercial mortgage loans, small business loans, etc.).

Majority of the loans went to commercial mortgage loans (churches and other non-profit facilities) and multi-family affordable housing units.
