Non-SDN Communist Chinese Military Companies Sanctions List (NS-CCMC List).

This publication by the Department of the Treasury's Office of Foreign Assets Control (OFAC) is designed as a reference tool that identifies persons subject to certain sanctions that have been imposed under statutory or other authorities, including certain sanctions described in Executive Order 13959, "Addressing the Threat from Securities Investments that Finance Communist Chinese Military Companies," as amended by Executive Order 13974 (the CCMC E.O. s).

The latest changes to the NS-CCMC List may appear here prior to their publication in the Federal Register, and users of this list can rely on changes indicated in this document. Such changes reflect official actions of OFAC or the Department of Defense and will be published as soon as practicable in the Federal Register. Users are advised to check the Federal Register and this electronic publication routinely for additional names or other changes to the NS-CCMC List.

Information that appears on the NS-CCMC List will be included in the data formats associated with the Consolidated Sanctions List.
