EXCHANGE STABILIZATION FUND
NOTES TO THE FINANCIAL STATEMENTS
As of June 30, 2019

1. The Exchange Stabilization Fund (ESF) carries several long-term instruments in its portfolio. Some of these instruments may have been purchased at a premium and others may have been purchased at a discount. These instruments are reported at cost. Cost is reflected as a face amount paid for the instrument plus any unamortized premium paid and less any unaccreted discount received.
Premiums (which are amortized) and discounts (which accrete) are allocated to expense (amortization expense) and revenue, respectively, over the life of the instrument.
2. Foreign currency denominated assets and liabilities are revalued daily -- and reported monthly -- to reflect fluctuations in market exchange rates. These fluctuations in market exchange rates are reported in the Statement of Income as "Net gain (loss) on valuation." This gain or loss is unrealized to the Exchange Stabilization Fund until such time as the Fund sells the currency.
3. The ESF has an exchange stabilization agreement with Mexico for \$9,000 million; this agreement was modified and renewed in November 2018 for an additional year. No drawings were outstanding under this agreement.
